# ATTENTION PERSONAL PROPERTY TAX PAYERS

Please be aware that if you owned the taxable unit on January 1<sup>st</sup> of the tax year YOU are liable for the tax. If you sold it during the tax year and didn't notify anyone, the tax bill is still in your name and YOU are still liable. If you sell your unit it is your responsibility to let the following person know who the new owner is and their current address and telephone number. On the back of this letter is a form to assist you with the process.

### TOWN OF MECAN TREASURER

When you sell the taxable unit we recommend that you work out an equitable division of the tax amount with the new purchaser. You will not know the current tax amount but normally you can use the previous year's tax and it will be close.

REMEMBER IF YOU OWNED IT JANUARY  $\mathbf{1}^{\mathsf{ST}}$  OF THE TAXABLE YEAR THE TAX IS YOUR LIABILITY UNLESS THE TOWN OF MECAN IS NOTIFIED OTHERWISE.

## POSTPONED TAX PAYMENT

If you have opted for the postponed payment method to pay your tax and you sell the taxable unit before the second payment if due, YOU are still liable for the second payment. The tax is for the prior year and the owner of the property in that year is still liable for the amount due.
