

**Resolution, 02-2022 of Town Board to Propose Exceeding Levy Limits**

Whereas, the State of Wisconsin has adopted levy limits on town, village, city and county levies for 2022 and thereafter under s. 66.0602 of Wis.Statutes;

Whereas, s. 66.0602 of Wis. Statutes limits the allowable local levy for 2022 to a percentage increase of no more than the greater of (a) 0% of the 2021 payable 2022 adjusted actual levy as calculated under the state's levy limit law\*\* or (b) a percentage equal to the percent change in equalized value due to net new construction; which for the Town of Mewan is 0.757 % percent;

Whereas, the Town Board of the Town of Mewan, Marquette County believes that for the 2022 tax levy (collected in 2023) it is in the town's best interest to exceed the state levy limit as described above by a greater percentage than (a) 0.757%.

Whereas, the Town of Mewan 2021 payable 2022 adjusted actual levy is \$136,869.00. And further whereas the state law would limit the increase to \$ 980.00 ( dollar amount allowed for net new construction less personal property aid) for an allowable town tax levy of \$137,849.00 , for 2022, collected in 2023.

Now Therefore the Town Board of the Town of Mewan, Marquette County, does hereby resolve and order as follows:

1. The town board supports an increase in the town tax levy for 2022 that will exceed the amount allowed by the state levy limit on a continuous basis.
2. The town board directs that the question of increasing the town tax levy for 2022 (to be collected in 2023) by 29.017 % percent , which would increase the town levy by \$ 40,000.00 for a total town tax levy of \$ 177,849.00, shall be placed on the agenda for the special town meeting to be held on November 7<sup>th</sup>, 2022.

**RESOLUTION 3-2022 BY TOWN ELECTORS TO ENDORSE THE TOWN BOARD'S  
RESOLUTION TO EXCEED THE LEVY LIMIT**

**Town of Mekan, Marquette County  
Resolution No. 03-2022**

Whereas, the State of Wisconsin has imposed levy limits on town tax levies for 2022 and thereafter under Wis. Stat. § 66.0602;

Whereas, Wis. Stat. § 66.0602(5) allows the town electors in a town with a population of less than 3,000 to exceed the maximum allowable levy limit by adoption of a resolution at a town meeting of the town electors;

Whereas, the town board has adopted a resolution supporting an increase in the town tax levy which would exceed the maximum allowable state levy limit for the Town of Mekan;

Whereas, a special town meeting of the town electors has been called and properly noticed to consider the adoption of a resolution to endorse a town board resolution to exceed the state levy limits, specifically by increasing the allowable town tax levy for 2022 (to be collected in 2023) by 29.017%;

THEREFORE, the special town meeting of the Town of Mekan, Marquette County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 7th day of November, 2022, hereby resolves and orders as follows:

1. the town electors of the Town of Mekan, Marquette County, Wisconsin endorse the town board resolution to increase the town tax levy for 2022 (to be collected in 2023) by 29.017% over the allowable 2022 levy, which is a dollar increase of \$40,000.00 over the allowable 2022 town tax levy on a continuous basis.
  
2. The town clerk shall properly post or publish this resolution as required by law under Wis. Stat. § 60.80(1)(a) within 30 days after its adoption.

**RESOLUTION OF TOWN ELECTORS TO ADOPT THE TOTAL TOWN TAX LEVY

Whereas, Wis. Stat. § 60.10(1)(a) authorizes the town electors of a town to adopt the town tax levy at a town meeting of the electors;

Whereas, a special town meeting of the town electors has been called and properly noticed to approve the 2022 total town tax levy (to be collected in 2023), pursuant to Wis. Stat. § 60.10(1)(a);

Whereas, the town electors, after proper notice, have, via a Special Town Meeting of Electors, vote, authorized the Town of Mekan, to exceed the allowable state levy limit;

THEREFORE, the special town meeting of the Town of Mekan, Marquette County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 7th day of November, 2022, hereby resolves and orders as follows:

1. The town electors of the Town of Mekan, Marquette County, Wisconsin adopt the total town tax levy for 2022 (to be collected in 2023) in the amount of \$ 177,849.00.
2. The town clerk shall properly post or publish this resolution as required by law under Wis. Stat. § 60.80(1)(a) within 30 days after its adoption.
