

**Notice of General Election  
and  
Sample Ballots**

TO THE VOTERS OF MARQUETTE COUNTY

Notice is hereby given of a general election to be held in Marquette County, on November 3, 2020, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office and under the appropriate party or other designation, each in its proper column, together with the questions submitted to a vote, in the sample ballot below.

**INFORMATION TO VOTERS**

Upon entering the polling place, a voter shall state his or her name and address, show an acceptable form of photo identification and sign the poll book before being permitted to vote. **If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for voting from the Division of Motor Vehicles.** If a voter is not registered to vote, a voter may register to vote at the polling place serving his or her residence if the voter provides proof of residence. Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the voter shall retire alone to a voting booth or machine and cast his or her ballot except that a voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward. An

election official may inform the voter of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

### **Voting for President and Vice President**

A vote for candidates for President and Vice President is a vote for the presidential electors of those candidates. A write-in vote for President and Vice President must designate the name of a presidential candidate. A write-in vote for a candidate for President only will be counted. A write-in vote for a candidate for Vice President only will not be counted.

### **Where Paper Ballots are Used**

The voter shall make an “X” or other mark in the square next to the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall write in the name of the person of his or her choice in the space provided for a write-in vote. When voting for President and Vice President, the voter shall make an “X” or other mark next to the set of candidates (ticket) for president and vice president for whom he or she intends to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall write in the names of persons of his or her choice in the spaces provided. On referendum questions, the voter shall make a cross (X) in the square next to "yes" if in favor of the question, or the voter shall make a cross (X) in the square next to "no" if opposed to the question.

### **Where Touch Screen Voting is Used**

The voter shall touch the screen at the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote. When voting for President and

Vice President, the voter shall touch the screen at the set of candidates (ticket) for president and vice president for whom he or she intends to vote. To vote for a Presidential ticket that does not appear on the ballot, the voter shall type in the names of persons of his or her choice in the spaces provided. On referendum questions, the voter shall touch the screen at "yes" if in favor of the question or the voter shall touch the screen next to "no" if opposed to the question.

The vote should not be cast in any other manner. Not more than five minutes' time shall be allowed inside a voting booth. Sample ballots or other materials to assist the voter in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

If a voter spoils a **paper** ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.

The voter may spoil a **touch screen** ballot at the voting station before the ballot is cast.

### **After Voting the Ballot**

After an official **paper** ballot is marked, it shall be folded so that the inside marks do not show, but so the printed endorsements and inspectors' initials on the outside do show. The voter shall then deposit his or her folded ballot in the proper ballot box or deliver the ballot to an inspector for deposit, and leave the polling place promptly.

After an official **touch screen** ballot is cast, the voter shall leave the polling place promptly.

A voter may select an individual to assist in casting his or her vote if the voter declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

Notes:

Assembly District 41 includes: Towns of Crystal Lake, Harris, Mecan, Montello, Neshkoro, Newton, Oxford, Packwaukee, Shields, Springfield and Westfield; Villages of Neshkoro, Oxford and Westfield; City of Montello.

Assembly District 42 includes: Towns of Buffalo, Douglas and Moundville; Village of Endeavor.
