We have already passed a Town Ordinance 01-01 (copy enclosed) authorizing us to get going and to start I am to establish the members of the Commission. Therefore, I am making the following appointments and for the term specified:

Remuneration for attending regular and authorized meetings has already been approved by the Town Board. The amount authorized was \$25.00 per meeting. Town Supervisors receive the same amount but they will include each meeting on their quarterly expense account. We anticipate that a system can be worked out whereby the Town will pay only once each calendar quarter.

It was suggested that the Planning Commissions first meeting should be held on Thursday April 26, 2001, 7:30 P.M., possibly at the Town Hall. Please let me know if for some reason this is not a good day for you. I must know that the meeting is on for the 26th by April 15 because we must comply with the open meeting laws and we need the time to put a meeting notice in the newspaper.

We have collected some information for you that will be handed out at our first meeting.
