February 11th 2020 Town of Mekan Regular Meeting called to order at 7:02p.m. Present , Brandon Frazer, Tom Breiling, Caroline Gemoll, and Valorie Schable. Excused Michael Raddatz

Minutes from the January 15th 2020 were read by Caroline Gemoll , motion to accept the January 15th meeting minutes by Tom Breiling , 2nd by Brandon Frazer. Passed

Jesse Schable - Insurance - Went over Town insurance policy. Brandon questioned the additional shed that was recently added 10x10. Jesse stated that being that shed was \$1500 and we have \$1000 deductible you would need to look at what is the best route for the shed and will get back to us. Submitted invoice. Val has correspondence check from the Department of Justice - Circuit Courts \$4.76 this was from a DNR ticket that was issued.

Adams Columbia sent a letter for the right of way to clear trees in the lines. Motion to approve by Tom Breiling and 2nd by Brandon Frazer.

Building permits - Assessor contacted Lake Arrowhead with a list of 4 changes that were not listed. Caroline stated that she reviewed building permits there 2 of the 4 had requested building permits. Adam went over the permits. 72L Adam stated that this person received a new camper but thinks the initial building permit was issued 2009 and believe that due to the new camper this was noticed by the assessor. Adam stated that the deck was still the same as the previous just opened up the deck to replace the new camper. Valorie stated that she also had one. Adam explained that Arrowhead purchased camper for a short time and sold the camper and this was missed. He is working on trying to get a system procedure so these will not be missed in the future. Adam will check with camper to complete a new permit when the deck roof was added and will pay the difference.

Zoning- All permits have been submitted for this month.

Correspondence: Caroline received notice that the State bureau of equalization will be in the area and gave a list of 4 cars that will be out in the county reviewing homes sold in 2019 they may even speak with owners and take pictures. She forwarded to the board in case they received calls.

Caroline also received a letter from the County Highway Department on using the County equipment for special events and the requirement that will be required by the County.
