January 9th 2017 Town of Mekan Regular Meeting called to order at 7:00 p.m. Present Michael Raddatz, Brandon Frazer, Nancy Reuter, Caroline Gemoll and Valorie Schable. Opened with Pledge of Allegiance by Michael Raddatz.
