

## Town of Mecan Regular Monthly Meeting -March 15th, 2021 1561 Evergreen Montello WI 53949 at 6:00 p.m.

March 15th, 2021 Town of Mecan Regular Meeting called to order at 6:05pm with the Pledge by Michael Raddatz . Present Brandon Frazer, Tom Breiling, Caroline Gemoll, Michael Raddatz and Valorie Schable.

Minutes from February 9th, 2021 Regular meeting were read by Caroline Gemoll. Motion to approve minutes by Tom Breiling , 2nd by Brandon Frazer. Passed.

Valorie Schable read the treasurer's report. Motion to put Treasurer's report on file by Brandon Frazer, 2nd by Tom Breiling.

Fire meeting update- Mike wanted to know what the conflict of interest was that was on the agenda. Tom Breiling attended the meeting, stating that it had something to do with the grant. We did get an invoice for the Scuba gear and an additional payment will be vouchered out for March vouchers. Brandon stated that we lost another 25yr veteran that has left due to management issues at the fire department. Brandon stated that they will have to hire an office employee to file all the administrative paperwork that Eric did as a volunteer.

Litigation - Mike stated that he has not been contacted by Attorney Sondalle. Brandon suggested that we drop discussion of it at this time.

Computer virus security- Brandon stated that we did not have to worry about this at this time as we are not on any server..

Roads- Mike stated that we will need to do something about the culverts and they should all be on GPS. Brandon stated that he will look at getting some maps, so that we can create a map with culverts and GPS.

Culvert ordinance - Brandon stated that he reviewed the culvert ordinance and believes it has everything in it that the town will need.d Mike will revise the wording and add the ordinance heading and send it to Caroline to publish.

Valorie wanted to know about posters for labor law. We have posters up in the town. Valorie also wanted to know if we have a comprehensive plan. Our copy is in the files and the county/town website.

Old business - Mike wanted to know what was going on with the Storage unit. Advised last meeting that owners will have to roof and side it by June 15th.
