Highway meeting from October 3, 2017. Town of Mekan LRIP, Advised that we should only try to do one road. Town of Mekan portion is \$11153.79 Mike reviewed roads and wants to do Tomahawk Trail. Dump trucks ruined the corner on East Tomahawk Trail. Chip Sealing 15,000 a mile. Would cost estimated \$40,800. Then both subdivision would be good for next 10 years.

Brandon asked about crack sealing. Stated there was some out of Cross Plains that they blow out the cracks and do a better job. Mike will discuss with the County.

Scotts sealed road twice due to rain, they will reseal in spring. Due to all the towns eligible for the grants monies, purchasing material together cost is lower.

Old Business, Building permits = Caroline advises all up to date and all permits match up with county permits.

Caroline advised that we have received fire bill reimbursement . Mike has golf cart permits. Highway bill from Hanke the last mowing, Caroline advised that we are vouchering out check with the October. Mike also received
