

Town of Mecan Regular Meeting June 12th, 2024, at the Town Hall, 1561 Evergreen Lane Montello, WI. 53949 at 6:00 p.m. Present: Michael Raddatz, Caroline Gemoll. Valorie Schable, Tom Breiling and Nicole Carneal-Frazer.

Called to order at 6:00 p.m. with pledge.

May 8th, 2024, Meeting minutes, were read by Caroline Gemoll. Motion to approve minutes by Mike Raddatz, 2nd by Tom Breiling.

Treasurers report read by Valorie Schable. Motion to put the treasurers report on filed by Tom Breiling 2nd by Nicole Carneal- Frazer. Disbursements \$8,806.55 Deposits \$4,793.01 and checkbook balance \$151,526.87,

Nicole Carneal- Frazer resigned- Mike Raddatz appointed Jake Schueller as Supervisor for the remainder of Nicoles term. Caroline gave the Oath of office to Jake Schueller.

Liquor licenses for Good Old Days, Log Cabin, Lake Arrowhead, Mecan River Lodge and Rusty's White Lake Golf Club. A list of bartenders was also given. Motion to approve all Liquor licenses and bartender licenses by Mike Raddatz, 2nd by Tom Breiling. Passed.

DOR (Department of Revenue) Maintenance report due for EMS and Fire department. Caroline was waiting for the fire department to submit. Mike gave Caroline the report. She will file the report and Mike requested a copy of the report when filed.

Raise or repair for Lawn Avenue- Mike stated that he received a complaint on the property. The property has not received any maintenance for a long time. There are trees down on the roof of the house and ground maintenance is not being done. He will talk to the county about the process.

Citizens comments- Valorie Schable wanted to know how the board of review went. Valorie was advised that no property owners came to the review.

Maddy Wergin reported on the Lake District. Maddy said they still need to set up a budget and are working with a lawyer to review the process. The district is working on their funds balance. They are working on a lake management plan. Tom stated that by killing off the Milfoil opens the lake up for curly leaf weeds.

Zoning – House that needs to be raised. Caroline stated that she has not received any reports from Jean Potter and has emailed her about the reports with no response.

Correspondence- Mike has the fire department maintenance of effort report and form. Caroline received MFL, (Managed Forest Land), to continue MFL for parcels.

Maddy Wergin wanted to know if there were any zoning ordinances preventing her from putting up a two-story home. They were advised that they must go through zoning for soil testing first and there should not be any issue with two story home if the setbacks are in line.
