Mike has bill from Henke for mowing. 19th street from Scott Construction and that we may have to get the road surveyed. Jason will fix the map as survey will cost too much for the 100 ft. Mike asked about the Scotts bill that is being paid. The 2nd bill for 19th for estimated 11855 instead of 8600 so it is 3255 over the estimated amount. Scotts took the chip sealing to the end. Mike will contact Scott's Construction on the bill.

Mike want over the budget for road maintenance. Val's report is one month behind and the budget report reflects updated highway billing with current bill's being vouchered out. Went over some of the budget numbers.
