ORDINANCE NO. 03-01

Establishing Jurisdiction and Duties of Town Constable

The Board of the Town of Mecan, Marquette County, Wisconsin does hereby ordain as follows:

- 1. Pursuant to Town Board action at the regular meeting on , 2001, Ordinance No. 03-01, Establishing the Jurisdiction and Duties of the Town of Mecan Constable, is hereby created pursuant to Sec. 60.22 (4) of the Wisconsin Statutes.
 - 2. Ordinance No. 03-01 establishes the following Jurisdiction and Duties of the Town Constable:
 - (a) To act on behalf of the Town Board, as directed, to:
 - (1) See that Town orders and ordinances are obeyed through the use of oral or written communications.
 - (2) Refer back to the Board, for their action, those cases that do not comply after communications were utilized.
 - (3) Refer to the Sheriff's Department, Health Department or any other duly authorized law enforcement organization, all violations of State and County ordinances and laws of which the Constable has knowledge or information.
 - (4) Obtain necessary assistance, if available, in case of emergency, except as provided under Chapter 166 of the Wisconsin Statutes for emergency government.
 - (5) Perform the duties as specified in the Towns Municipal Plan that specifies Municipal Emergency Operations during a disaster.

3. Nonexclusivity:

- (a) Other ordinance. Adoption of this ordinance does not preclude the Town Board from adopting any other ordinance or providing for the enforcement of any other law or ordinance relating to the same or other matter.
- (b) Other remedies. The jurisdiction and duties of the Town Constable as stated herein shall not preclude the Town Board or any other Town Officer from proceeding under any ordinance or law or by any other enforcement method to enforce any ordinance, regulation or order.

4. Serverability:

If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not effect the provisions or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision, or application.
