

MARQUETTE COUNTY - MUNICIPALITY  
RECYCLING COOPERATIVE AGREEMENT

This cooperative agreement is entered into this  
9<sup>TH</sup> Day of MARCH 1993, by and between  
MARQUETTE COUNTY, Wisconsin, hereinafter referred to as  
the COUNTY, and the TOWN OF MECAN, Wisconsin, hereinafter  
referred to as the MUNICIPALITY.

ARTICLE I

The purpose of this agreement is to designate by  
contract, pursuant to Section 66.30 of the Wisconsin  
Statutes, MARQUETTE COUNTY as the responsible unit, under  
Section 159.09 of Wisconsin Statutes for the MUNICIPALITY.  
Furthermore, this agreement establishes the responsibility  
of the COUNTY to fulfill the requirements of Wisconsin Act  
335 to operate an effective recycling program and manage  
recyclable materials.

ARTICLE II

TERM

The term of this agreement shall be for a period  
of three (3) years commencing on the date this agreement is  
executed.

RENEWAL OF AGREEMENT

The term of this agreement shall be renewed for  
an additional term of three (3) years, and shall continue  
to renew for successive three (3) year terms from the date  
the agreement is signed.

WITHDRAWAL OPTION

The MUNICIPALITY shall have the option to withdraw  
from this contract and establish itself as a responsible  
unit upon one hundred twenty (120) days notice to COUNTY.  
This option to withdraw shall only be effective upon a  
majority vote of the governing body of the MUNICIPALITY  
executing this agreement.

OTHER TERMS

Termination of or withdrawal from this agreement  
shall not result in the refund of any payments made or  
assigned to the COUNTY by the MUNICIPALITY.

MARQUETTE COUNTY-MUNICIPALITY RECYCLING COOPERATIVE AGREEMENT

ARTICLE III

RESPONSIBLE UNIT DESIGNATION

The MUNICIPALITY hereby agrees to designate the COUNTY as the responsible unit, for developing and implementing an effective recycling program pursuant to Wisconsin Statute 159.09. The COUNTY hereby accepts such designation and agrees to assume the duties of responsible unit as provided in Chapter 159 Wisconsin Statutes.

AMENDMENTS

The COUNTY and the MUNICIPALITY agree that this initial agreement shall be further amended and/or supplemented as agreed upon in writing by both parties, so as to implement the COUNTY'S effective recycling program to and for the benefit of the parties, and so as to comply with Chapter 159 as now in force and effect or as hereafter amended.

ARTICLE IV

The MUNICIPALITY has an agreement between the TOWN OF MONTELLO and the CITY OF MONTELLO to use their dump site for recycling.
