RESOLUTION NUMBER 1-98

Relating to the Town of Mekan Town Board approval of the stop signs within the Township as they exist on today's date.

The Town Board of Supervisors of Mekan Township, Marquette County, Wisconsin, duly assembled at its regular meeting begun on the 20th day of January, 1998, does resolve as follows:

WHEREAS, for the safety and well being of all persons residing in or traveling within the Township and

WHEREAS, it is deemed necessary, for safety sake, to control traffic at many intersections, and

WHEREAS, the placement of stop signs is not mandatory as per State Statutes and is left up to the Townships discretion, and

WHEREAS, there are a few locations within the Township where the intersection does not have a stop sign and the Town Board does not deem it necessary at this time to place anymore signs.

NOW, THEREFORE, BE IT RESOLVED, that the attached listing of all stop signs within the Township (dated December 15, 1997) be approved and included in the minutes as a permanent record.

Re: Current prices of various signs such as stop, street, private road and golf carts.

All stop signs and signs placed on Town right of way for caution etc. must be placed following State specifications, therefore, we can only allow them to installed by our County sign person. Other signs such as Private road or Street signs may be put up by the property owner.

** About 4 signs can be put up in an hours time, therefore, if you divide the number of signs (4 or less) into these figures your per sign cost will be less. If more than one can be done at the same time the cost would be for one sign - \$62.60, for two signs - \$45.30, for three signs - \$40.34, and for four signs - \$36.65.

If more than one can be installed at the same time, the cost would be for one sign - \$69.60, for two signs - \$52.30, for three signs - \$47.34. an for four signs - \$43.65.
