Motion for acceptance of roads in White Lake Country Club Plats 3 & 4 to be included in the regular meeting minutes of the Town Board held on October 8, 2002.

Upon a motion by Earl H. Ewert it was moved that it be hereby resolved that the Town Board of the Town of Mecan hereby accepts as Town roads the following roads in White Lake Country Club Plats 3 & 4 which were inspected and found to exceed the Ordinance requirements for roads:

- Deer <sup>E.H.E.</sup> Path Drive
- Eagle Circle
- Pine Drive
- Peacock Lane
- Golf Ridge Drive
- Golf Ridge Circle

It is also agreed upon that the White Lake Country Club will maintain all of the shoulders on these roads until such time as it is agreed upon that the shoulders are established with grass vegetation to control erosion. White Lake Country Club will also pay the year 2002 property taxes on these roads.

Golf Ridge Drive


Eagle Lane
