Website- Brandon stated that it is currently down and that they need to transfer things to fix what they broke.

Dennis Kamin stated that a tax box on the porch is not a good idea. Valorie stated that people just try to stick their taxes in her door and did not want them blowing away. Dennis suggested putting a lock on the box. Valorie will put a lock on the box. She checked the drop box and there was a tax bill that was dropped off.

Dennis Kamin also asked if the EMS billing with the Fire department was cleared up. Brandon Frazer stated that dispatch should get everything correct now going forward.

Dennis Kamin asked if the County does damage to the roads while plowing and do they fix the roads they damage. The county does not pay to fix the damages the Town is charged.

Building permits -Peacock Lane building home and garage. Valorie had correspondence from First National bank about fees. Valorie stated that we do not need copies of deposits or checks. They will no longer be on file. They also want to charge \$10/mth for checking. Valorie said they will not be charging us this fee.
